<p>Debt Recovery</p>	If the customer defaults on any repayment, the Bank has the right to employ and disclose the customer’s data to third party debt collection agencies (whether within or outside Hong Kong) to collect, recover, attempt to collect/recover the debt owed by the customer and to enforce the Bank’s rights. The customer will be liable for all reasonable charges, other costs and expenses reasonably incurred in the debt recovery process (including without limitation all reasonable legal charges, other costs and expenses reasonably incurred in connection with the Bank’s effort in debt recovery), to the extent of 30% of the total outstanding amount . - Remarks: 1. The default interest shall be calculated with regard to the amount overdue on the basis of 365-day year.
2. Partial prepayment will not be allowed. Early full repayment of the loan is permissible with not less than 7 business days' prior written application thereof having been received by the Bank. The customer agrees to pay to the Bank the entire outstanding loan principal (including any arrears), outstanding handling fee and interest up to the next repayment date together with all fees and charges due under the loan in full and the customer also agrees to pay to the Bank a prepayment fee which the Bank may at its absolute discretion determine from time to time, as at the time of approval of early repayment.
3. Outstanding principal amount of the loan is calculated according to the formula known as the “Rule of 78”. The “Rule of 78” is the calculation of the interest and principal repayment and the allocation of the two components. In principle,

customer's repayment will be utilised to settle the interest prior to the principal. A larger proportion of the repayment made in the early stages is allocated to settle the interest and finance charges, with a smaller proportion to repay the principal. Such allocation of the repayment will reverse after more instalments have been made while the total interest expenses will remain unchanged. The Bank reserves the right at its discretion to apportion the monthly repayment amount of the loan.
