Processing of Personal Data as part of the Stock Connect Northbound Trading

閣下確認並同意,在創興證券有限公司(下稱「本公司」)為 閣下提供滬深股通交易服務的過程中,本公司按要求必須: You acknowledge and agree that in providing our Stock Connect Trading Services to you, Chong Hing Securities Limited ("we" or the "Company") will be required to:

- (i) 在遞交至內地交易所的每個北向買賣盤中附加「**券商客戶編碼**」,而該等「券商客戶編碼」應是唯一編派予 閣下或 閣下之聯名賬戶(如有);及
 - tag each of your orders submitted to the Mainland exchanges with a Broker-to-Client Assigned Number ("BCAN") that is unique to you or the BCAN that is assigned to your joint account (if any); and
- (ii) 向香港聯合交易所有限公司(「聯交所」)提供 閣下的「券商客戶編碼」及聯交所根據《交易所規則》不時要求提供 閣下相對應的識別信息(「**客戶識別信息**」)。
 - provide to the Stock Exchange of Hong Kong Limited ("SEHK") the assigned BCAN and such identification information ("Client Identification Data" or "CID") relating to you as SEHK may request from time to time under the Rules of the Exchange.

Without limitation to any notification we have given to you or consent obtained from you in respect of the processing of your personal data, you acknowledge and agree that we may collect, store, use, disclose and transfer your personal data as required as part of our Stock Connect Northbound Trading Service, including:

- (a) 不時向聯交所及聯交所子公司披露及轉移 閣下之「券商客戶編碼」和「客戶識別信息」,包括在 閣下遞交的北向買賣盤中附加上「券商客戶編碼」,並實時轉遞至內地交易所; to disclose and transfer your BCAN and CID to the SEHK and the relevant SEHK Subsidiaries from time to time, including
 - tagging your BCAN when submitting the northbound orders, which will be routed to the Mainland exchanges on a real-time basis;
- (b) 同意聯交所及聯交所子公司(i) 收集、使用及儲存 閣下之「券商客戶編碼」和「客戶識別信息」以及中國結算所提供的任何已綜合、核實和配對的「券商客戶編碼」和「客戶識別信息」資料(就儲存而言,可經由上述任何機構或香港交易所進行),以作市場監控和監察目的及執行《交易所規則》;(ii) 就以下(c)及(d)段所述目的,不時向內地交易所(直接或透過中國結算)轉移此等資料;及(iii)向在香港的相關監管機構及執法機關披露此等資料,以助他們履行有關香港證券市場的監控、監察及執法職能;
 - to allow each of the SEHK and the relevant SEHK Subsidiaries to: (i) collect, use and store your BCAN, CID and any consolidated, validated and mapped BCANs and CID information provided by the relevant China Connect Clearing House (in the case of storage, by any of them or via HKEX) for market monitoring and surveillance purposes and enforcement of the Rules of the Exchange; (ii) transfer such information to the Mainland exchanges (directly or through the China Connect Clearing House) from time to time for the purposes set out in (c) and (d) below; and (iii) disclose such information to the relevant regulators and law enforcement agencies in Hong Kong so as to facilitate the performance of their monitoring, surveillance and enforcement functions with respect to the Hong Kong financial markets;
- (c) 同意中國結算 (i) 收集、使用及儲存 閣下的「券商客戶編碼」和「客戶識別信息」,以便綜合及核實「券商客戶編碼」和「客戶識別信息」,並將此類信息與其本身的投資者身份數據庫進行配對,以提供給內地交易所、聯交所和聯交所子公司;(ii) 使用 閣下之「券商客戶編碼」和「客戶識別信息」來協助其履行證券賬戶管理的監管職能;及 (iii) 向管轄中國結算的內地監管機構及執法機關披露此等資料,以助他們履行有關內地證券市場的監控、監察及執法職能; to allow China Connect Clearing House to: (i) collect, use and store your BCAN and CID to facilitate the consolidation and validation of the BCANs and CID and the mapping of such information with its own investor identification database for providing to the Mainland exchanges, SEHK and the SEHK Subsidiaries; and (ii) use your BCAN and CID for the performance of its regulatory functions of securities account management; and (iii) disclose such information to the Mainland regulatory authorities and the law enforcement agencies having jurisdiction over it so as to facilitate performance of their monitoring, surveillance and enforcement functions with respect to the Mainland securities markets;

(d) 同意內地交易所(i) 收集、使用及儲存 閣下之「券商客戶編碼」和「客戶識別信息」,以助其就滬深港通下在內地交易所進行的證券交易進行監管與監察及執行內地交易所規則;及(ii)向內地的監管機構及執法機關披露此等資料,以助他們履行有關內地證券市場的監管、監察及執法職能。

to allow each of the Mainland exchanges to: (i) collect, use and store your BCAN and CID to facilitate their supervision and surveillance of securities trading on the Mainland exchange under Stock Connect and enforcement of the rules of the Mainland exchanges; and (ii) disclose such information to the Mainland regulatory authorities and law enforcement agencies so as to facilitate performance of their supervision, surveillance and enforcement functions with respect to the Mainland securities markets.
