

## General Terms and Conditions of Chong Hing Credit Card "The Year of the Dragon Spending Rewards" Programme (Only available for offer 1-4)

- 7. A computer system will be used to calculate the transactions and rewards. The records of the Bank shall be final and conclusive.
- 8. The Bank reserves the right to change, suspend or terminate the above offers and rewards or to amend the Terms and Conditions without prior notice. The Bank reserves the right of final decision.
- 9. Eligibility of this promotion shall be determined based on the transaction date and time of the transaction in the Bank' s record. If there is any discrepancies between the Bank' s record and Cardholder' s record, the Bank' s record shall prevail (save for manifest error, negligence or fraud related to the Bank). Unless otherwise specified, all spending transactions must be made during the Promotion Period based on the transaction dates.
- 10. Cardholders must retain all original transaction sales slips for record. In case of any



disputes, the Bank reserves the right to request the Cardholder to provide the original transaction sales slip(s) and/or such further documentation or evidence for verification. All sales slips and/or such further documentation submitted to the Bank will not be returned. The Bank' s decision is final and binding on the Cardholders and all participants, and the decision of the Bank and the relevant Merchants shall be final.

These Terms and Conditions shall be governed by and constructed according to the laws of the Hong Kong Special Administrative Region ("Hong Kong") of the People's Republic of China but the Contracts (Rights of Third Parties) Ordinance (Cap 623 of the Laws of Hong Kong) shall not apply to this promotional programme, the relevant rewards and these Terms and Conditions. The Cardholder acknowledges that he/she is subject to the Bank's Notice to Customers and other Persons relating to the Personal Data (Privacy) Ordinance and privacy policy statement of the Bank.
