

Lucky Draw for First-Time Mobile Banking Login - Terms and Conditions

- 1. The "Lucky Draw for First-Time Mobile Banking Login" promotion ("Promotion") launched by Chong Hing Bank Limited (the "Bank") is subject to the following terms and conditions.
- 2. The period of the Promotion is from 20 November 2025 to 31 December 2025, both dates inclusive ("Promotion Period").
- 3. Eligibility:
- 3.1 The Promotion is only available to personal customer (Single Authority) who have never logged on to Chong Hing Mobile Banking/Internet Banking Services before 20 November 2025 ("Eligible Customer").
- 3.2 Each Eligible Customer who completes the first login to the Bank's Mobile Banking from 20 November 2025 to 31 December 2025 will be entitled to one lucky draw entry, with a maximum of one prize per customer. If an Eligible Customer fails to win the Grand Prize, Second Prize or Third Prize, they will be awarded the Fourth Prize. Customers who do not participate in the lucky draw within the specified period will be automatically awarded the Fourth Prize by default.

Customers who win cash vouchers must "claim" them within the validity period of the cash vouchers and redeem them to the Hong Kong dollar savings deposit account or Hong Kong dollar cheque current deposit account (designated account) they have chosen. Cash vouchers claimed after the expiration date will not be replaced or compensated. The number of Grand Prize, Second Prize and Third Prize is limited. The offer will end once all prizes are allocated, and no further notice will be given.

After the customer claims the cash voucher, the cash voucher will be deposited into the Eligible Customer's designated account no later than 31 January 2026 and reflected in the transaction record without further notice.
