

Chong Hing Bank “Roadshow Pre-registration Rewards” Promotional Programme General Terms and Conditions

 - a) Reward 1: Reward for Event Pre-registration
 - b) Reward 2: Reward for Applying for the Bank's Products

Reward for Document Submission	Upon an Eligible Card Application or an Eligible Account registration on-site at the roadshow venue, the customer must upload all of the following supporting documents via the online application form, or via the designated online document submission webpage on the Chong Hing Bank website^ at the roadshow venue: a) A copy of the Hong Kong Identity Card b) A copy of a valid travel document (including visa) c) A valid residential address proof issued within the last three months d) A copy of a valid student card (front and back)	HK\$100 supermarket cash voucher*
c.
